- a monthly cash dividend of \$0.132813 per share of 6.375% Non-cumulative Monthly Income Preferred Stock, 2003 Series A, payable on July 31, 2019 to holders of record as of July 15, 2019; and
- a monthly cash dividend of \$0.171875 per share of 8.250% Non-cumulative Monthly Income Preferred Stock, Series B, payable on July 31, 2019 to holders of record as of July 15, 2019.
